REORGANIZING THE MUNICIPAL ADVISORY COMMITTEE (MAC) OF SAN VICENTE, ILOCOS SUR FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps)

WHEREAS, the Municipal Government of San Vicente has partnered with the Department of Social Welfare and Development (DSWD) for the implementation of the Pantawid Pamilyang Pilipino Program (4Ps) in the municipality since 2016;

WHEREAS, the leadership is aware of the benefits of the program to its constituents, such as poverty reduction and empowering the poor through the provision of health, nutrition, and education services;

WHEREAS, there is a need to create an Advisory Committee at the municipal level to ensure the efficient operation and effective implementation of the program;

NOW THEREFORE, I, **JONAN D. TABANDA**, Municipal Mayor of San Vicente, Ilocos Sur, by virtue of the powers vested in me by law, do hereby reorganize the Municipal Advisory Committee (MAC) for the Pantawid Pamilyang Pilipino Program (4Ps) of this municipality.

SECTION 2. FUNCTIONS

1. Ensure the effective implementation of the Pantawid Pamilyang Pilipino Program (4Ps) in the municipality;
2. Ensure the availability of supply side on health, nutrition and education at program areas;
3. Provide necessary technical assistance and logical support to the program implementation;
4. Coordinate with various government agencies to ensure compliance with the Order;
5. Hold meetings regularly, or as needs arise;
6. Help promote and disseminate the program to different stakeholders; and
7. Prepare reports with issues and concerns to be submitted to the Regional/Provincial Advisory Committee.

SECTION 3: EFFECTIVITY. This Executive Order shall take effect immediately.
